- Lā Kūokoʻa was celebrated by kumu and haumāna.
- Kani ke 'ō was attended by over 500 people.
- Kanu students attended Parker Ranch Tree Lighting and shared mele.
- Makahiki games were held on 12/5 to 12/9.

### Kauhale Campus Program

Elementary – Keōmailani shared

- The second round of the LLI/BAS training has been completed. Two staff can now be trainers.
- Elementary Kauhale kumu are being innovative in their semester two curriculum.

• An in depth analysis of the current Math program will help to determine if adjustments need to be made. This will begin with grades K-1 and then include all elementary grades.

#### Middle/Secondary

- BIIF paddling has begun. (Aunty Kanani has asked for the schedule for paddling and soccer)
- The farm area of the Ag & Animal Husbandry is growing and developing more partnerships.
- Looking for a program to bring info. regarding vaping to the students.
- Papa Mele kumu is needed for Semester 2. Mana Mele pays for this 4 hr/wk position.

#### Ka 'Ohā Virtual Program

- Working on the course prep for semester 2.
- Surveys are out to kumu and staff regarding the first half of the year.
- Ka 'Ohā is participating in the Festival of Giving.
- DOE schools have denied Ka 'Ohā space at their facilities to do ELL and 504 evaluations.
  - o Naomi suggests going to the district offices on the individual islands for assistance.

#### Questions:

- Q What is the status of the vans? Have they been ordered and paid for?
- Q What is the Festival of Giving? This is a night market to sell items for Christmas and to celebrate the season. Aunty Kanani wants to be sure that the evening lights on the campus are on for this event and other night events. Kanoa says that Blue Light team also recommended that we have more lights on at night.
- Q What is the update regarding the fundraising proposal for the wa'a group. This will be sent later. The project group is trying to align their huaka'i with  $K\bar{u}$  i ka Lono and Spring Break.
- Q Has there been a problem getting the compression pay for the kumu? Kanoa explained that DOE is waiting to disburse the funds until all schools have sent in their paperwork.
- Q Does every teacher get the hard-to-staff funding? Kanoa explained that all staff at the brick and mortar schools get the funds.
- Q When do kumu express their intent to return? Later in the year.

#### **Committees**

Academic Committee – This committee met on 11/15. po'okumu discussed academic data.

Finance Committee – No meeting however the board talked about the construction costs at the last Board meeting. Governance Committee 11/29 Committee met to discuss 302D 12 to be sure that the Board is in compliance and to discuss the Board's part of the contract renewal application.
